

Training Online: COVID-19 Healthcare ETS Requirement

OSHA Requirement Summary

- The ETS is effective immediately,
- By July 6, employers must comply with most provisions
- By July 21, employers must comply with the physical barriers, ventilation and training requirements
- The ETS is effective for six months.

STATE REGULATION 1910.502 (n)	CAREACADEMY CLASSES
The employer must ensure that each employee receives training, in a language and at a literacy level the employee understands, and so that the employee comprehends at least the following:	
COVID-19, including how the disease is transmitted (including pre-symptomatic and asymptomatic transmission), the importance of hand hygiene to reduce the risk of spreading COVID-19 infections, ways to reduce the risk of spreading COVID-19 through the proper covering of the nose and mouth, the signs and symptoms of the disease, risk factors for severe illness, and when to seek medical attention;	CARE0706 - Overview of COVID-19
